##### **Bradley Campbell**

New Jersey Department of Environmental Protection

Bradley Campbell is the New Jersey Commissioner of Environmental Protection, a state agency dedicated to assisting New Jersey residents preserve, sustain, protect, and enhance the environment and to ensure the integration of high environmental quality, public health, and economic vitality. Mr. Campbell formerly served as the EPA's Regional Administrator for the Mid-Atlantic Region in the Clinton Administration, where he was responsible for leading, implementing, and enforcing federal environmental laws.

From 1995 to 1999, Mr. Campbell was responsible for all toxic and environmental matters as the Associate Director of the White House Council on Environmental Quality. He has also served as an attorney-advisor for the U.S. Department of Justice, Environment and Natural Resources Division. From 1990-1994 he was an attorney-advisor for the U. S. Department of Justice, Environment and Natural Resources Division, where he was responsible for trial and appellate litigation and advised client agencies and the Assistant Attorney General on a range of environmental issues.

Mr. Campbell earned his J.D. from the University of Chicago Law School and his B.A. in history from Amherst College. He currently serves as Board Chairman of Echo Hill Outdoor School, a nonprofit organization that sponsors environmental education programs for school children in the Chesapeake Bay area. Mr. Campbell is also on the Board of Directors of Common Ground Community, a nonprofit organization that provides housing, social services, and job training to mentally ill, low-income, and formerly homeless persons.

##### **Dr. Lynn Goldman**

Johns Hopkins University School of Public Health

Dr. Lynn Goldman is a professor of Environmental Health Sciences and Occupational and Environmental Health at the Johns Hopkins School of Public Health. She researches children's health and environmental exposures, public health practices, and chemical and biotechnology safety.

Dr. Goldman leads the Maryland Mothers and Babies Study at Johns Hopkins as well as the Johns Hopkins division of the NICHD's Longitudinal Investigation of Fertility and the Environment study. She also heads the MidAtlantic Public Health Training Center, and directs the Bloomberg Center for Academic Public Health. Her work has been published in numerous

publications, and she has been recognized by the National Academy of Science and the National Library of Medicine.

Dr. Goldman received a B.S. and M.S. from the University of California, Berkeley, an M.P.H. from Johns Hopkins University, and a M.D. from the University of California, San Francisco.

**John Paul**

Regional Air Pollution Control Agency (RAPCA)

John Paul is the director of the Regional Air Pollution Control Agency (RAPCA) of Dayton, Ohio. RAPCA is a local air pollution agency, which is responsible for permit reviews, inspections, enforcement, air quality monitoring, and various other duties.

Mr. Paul is the co-chair of the New Source Review Committee of State and Territorial Air Pollution Program Administrators/Association of Local Air Pollution Control Officials (STAPPA and ALAPCO). He serves as legislative liaison for the Ohio Local Air Pollution Control Officers Association and is the past co-chairman of the STAPPA/ALAPCO Criteria Pollutants Committee. Mr. Paul also serves on several EPA national committees, including the Clean Air Act Advisory Committee; he recently co-chaired the Clean Air Act Advisory Committee's working group on utility emission control technologies.

Mr. Paul holds a Bachelor of Science degree from Michigan State University and a Master of Science degree from Iowa State University.

**David Foerter**

Institute for Clean Air Companies

David Foerter is the Executive Director of the Institute for Clean Air Companies. The ICAC is the national association of companies that supply air pollution controls for stationary and mobile sources of air pollution.

Before joining ICAC, Mr. Foerter served for seven years at the Ozone Transport Commission (OTC) in the development and implementation of interstate air pollution control programs. At the OTC, Mr. Foerter served as a lead negotiator for states in constructing the National Low Emission Vehicle Program (NLEV), a voluntary national vehicle emissions program with the automobile industry; and was key in the design, development, and implementation of the OTC Memorandum of Understanding (MOU) for Stationary Source NO<sub>x</sub> Reductions.

Before the OTC, Mr. Foerter managed the air programs for the Metropolitan Washington Council of Governments (Wash COG), the region's planning organization, where he coordinated a broad range of regional air pollution assessment, control, and abatement activities for states and local governments.

**Scott Sparlin**  
New Ulm Area Sportfishermen

Scott Sparlin is the president of the New Ulm Area Sportfishermen in Minnesota. He is also the Executive Director of Citizens for a Clean Minnesota River. In 2002, he served as the Friends of the Minnesota Valley's first Watershed Initiative Coordinator. He is also a Minnesota River guide.

Mr. Sparlin has extensive experience in community organizing, and natural resources conservation advocacy. He has hosted his own daily radio fishing show and written a newspaper column, and has been featured on numerous television programs and news broadcasts.
