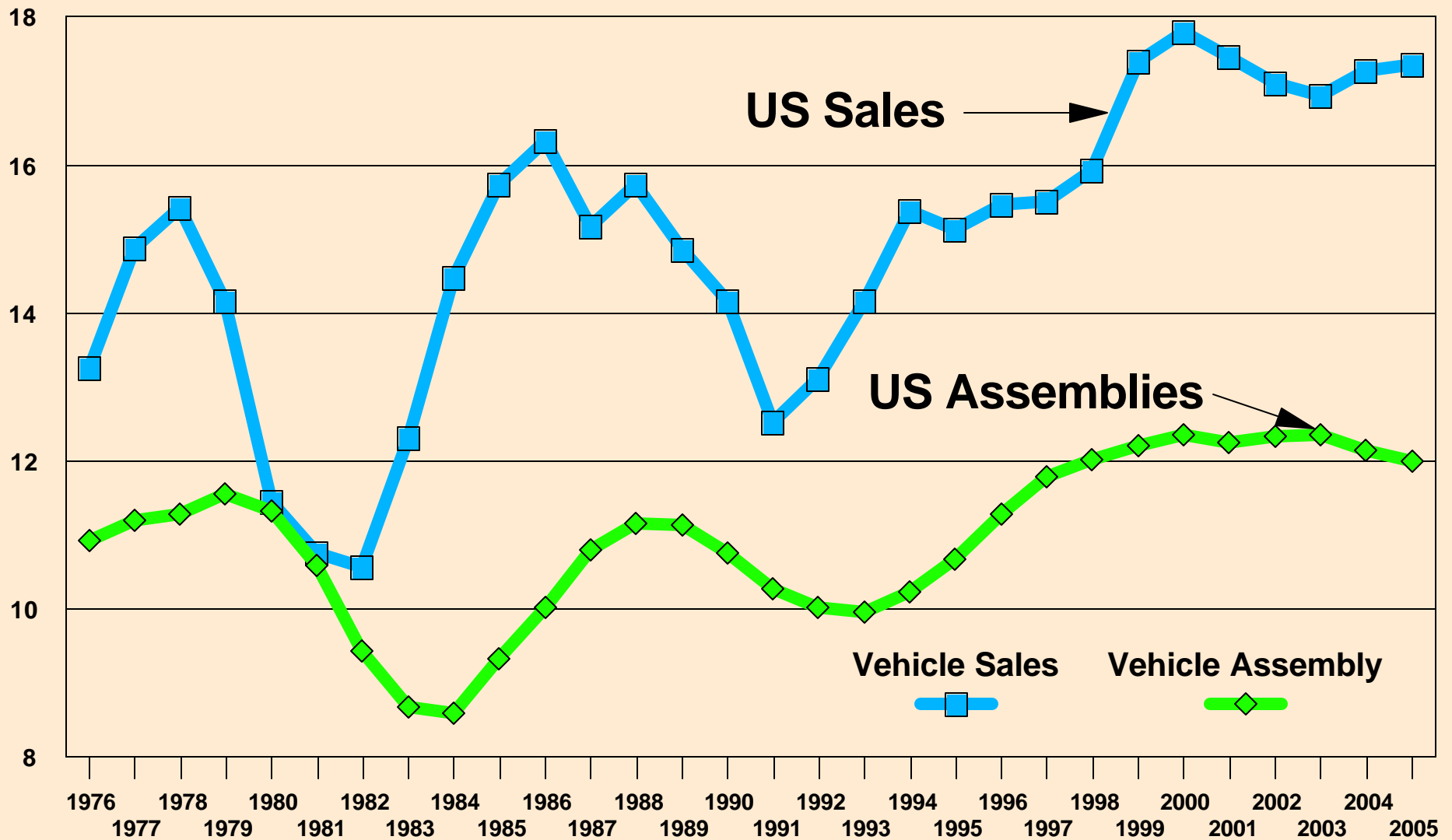


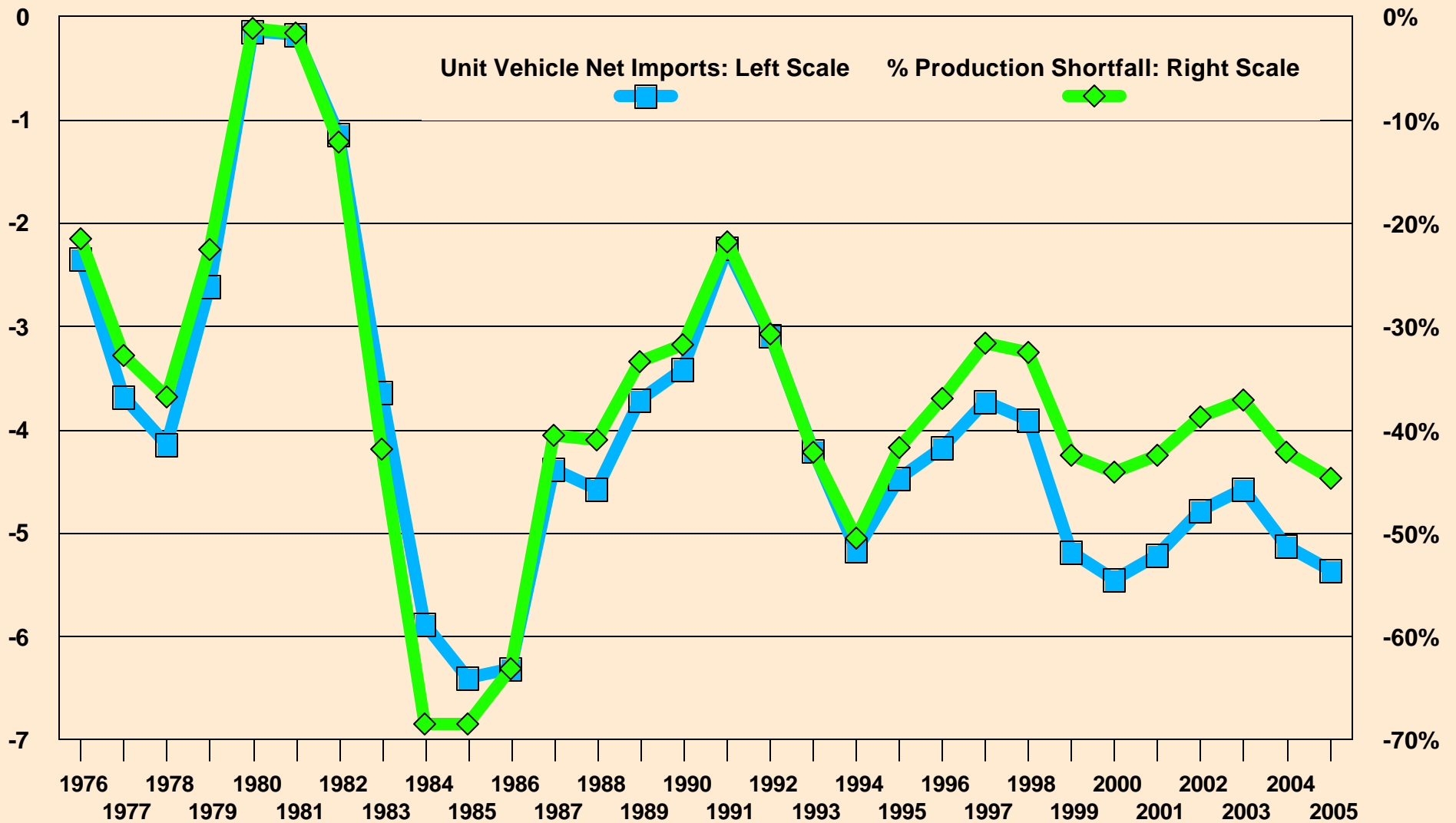
US Vehicle Sales and Assemblies

Million Units of Cars, Trucks and Other Vehicles Each Year



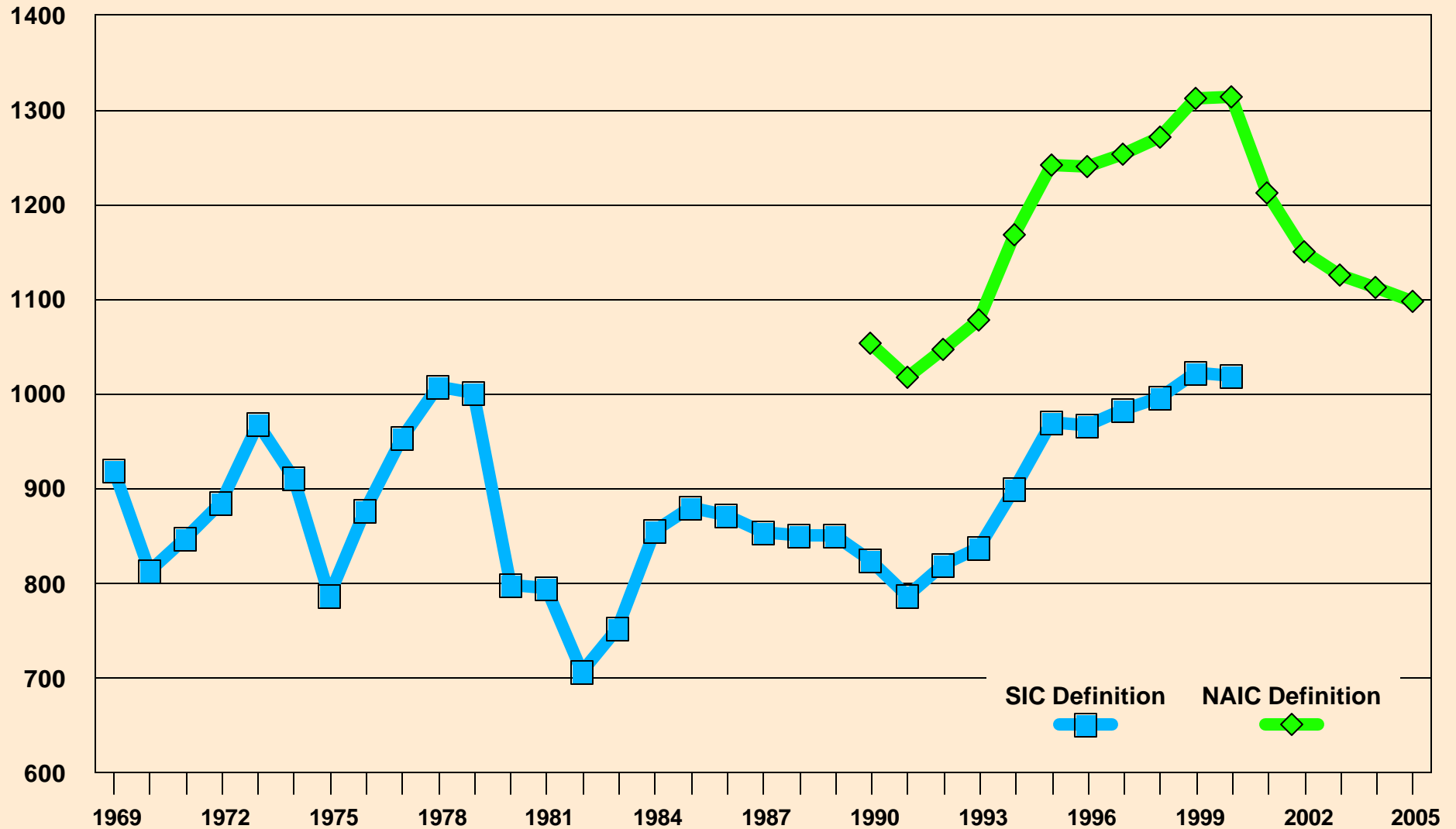
US Vehicle Net Imports/Production Shortfall

US Jobs in Vehicle/Parts Manufacturing

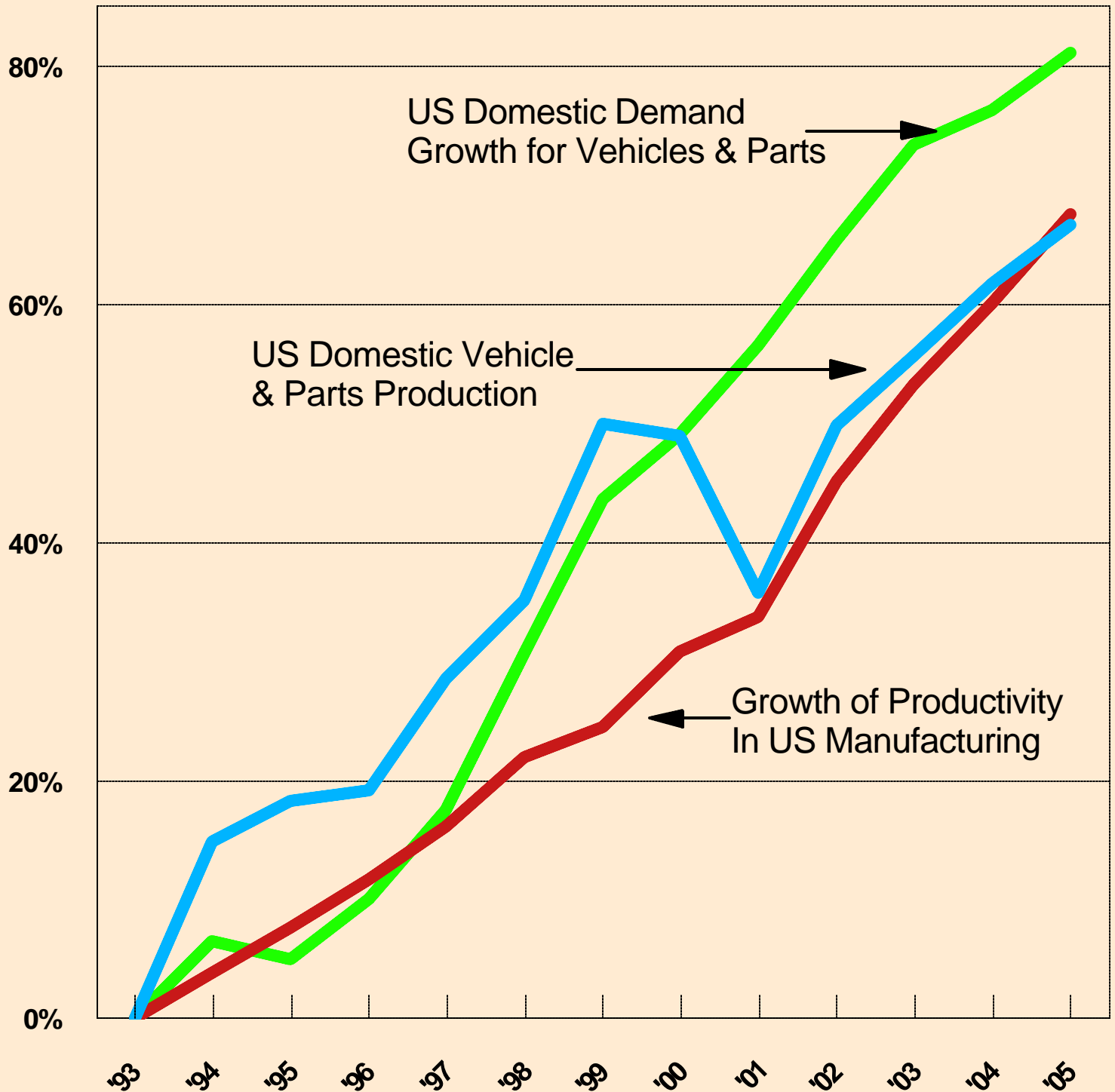
1,000s of Jobs in Vehicles/Parts Manufacturing Each Year

While US Production Now Lags Far Behind

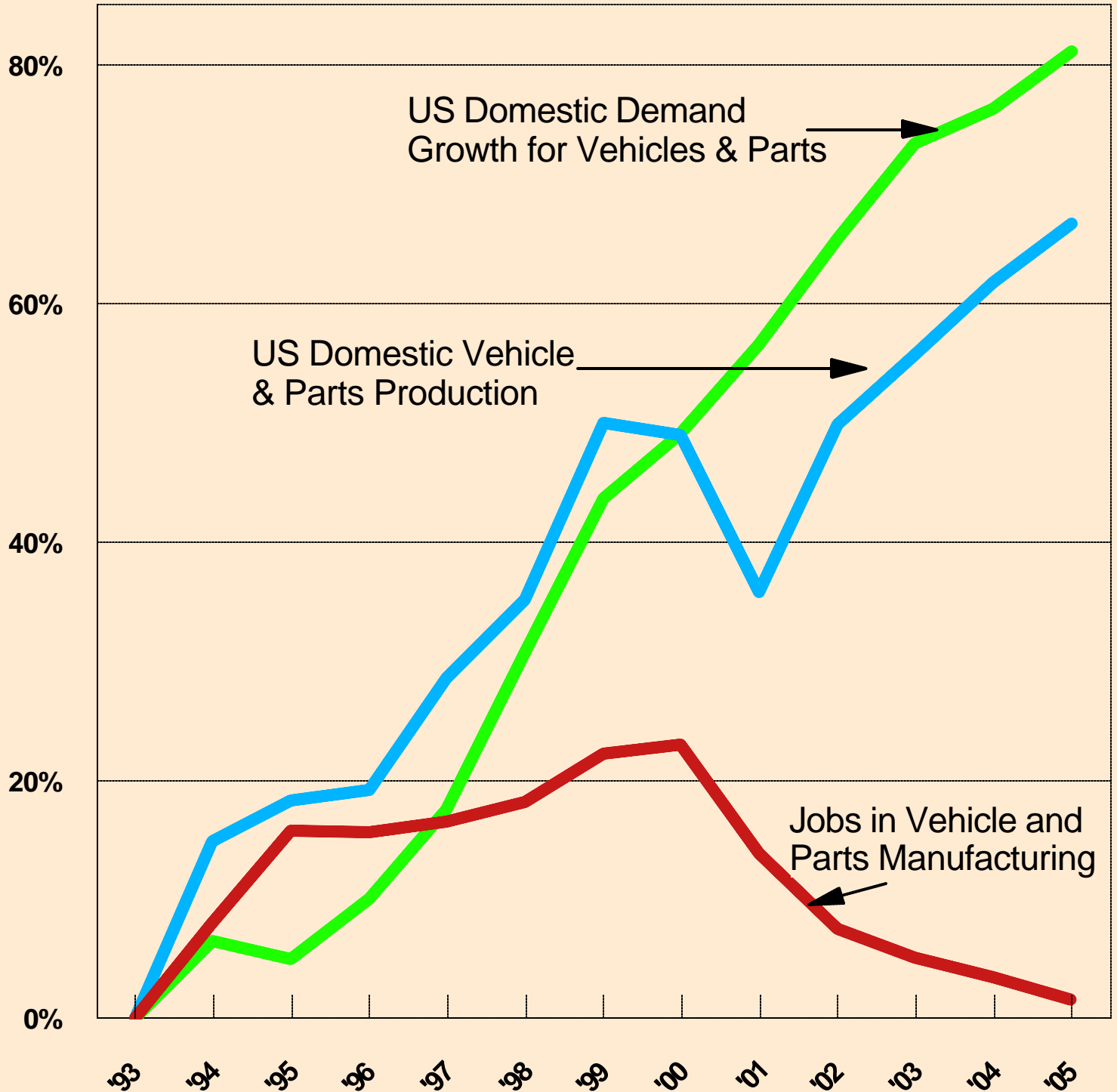
% Volume Growth and Decline Since 1993

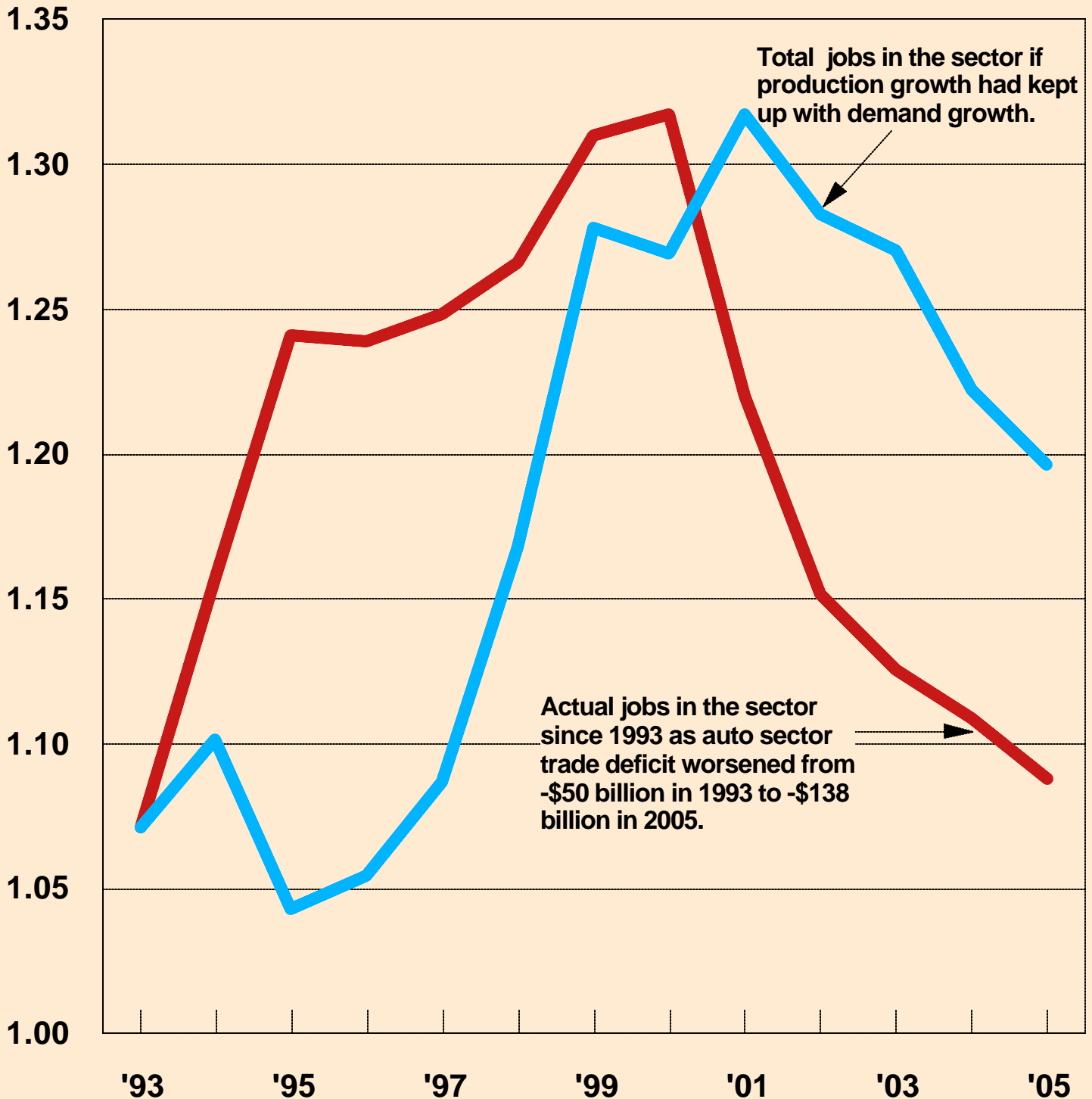

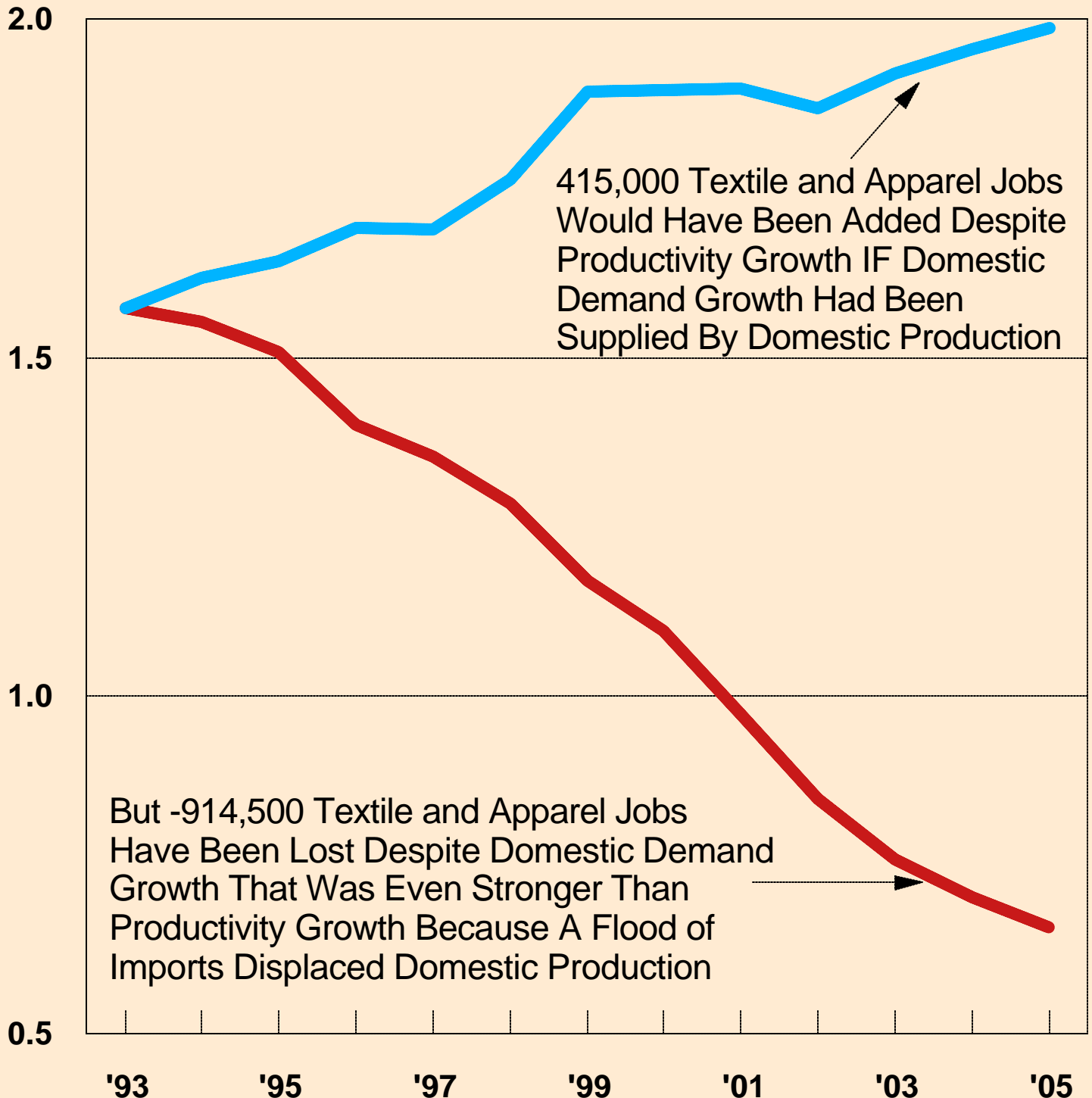

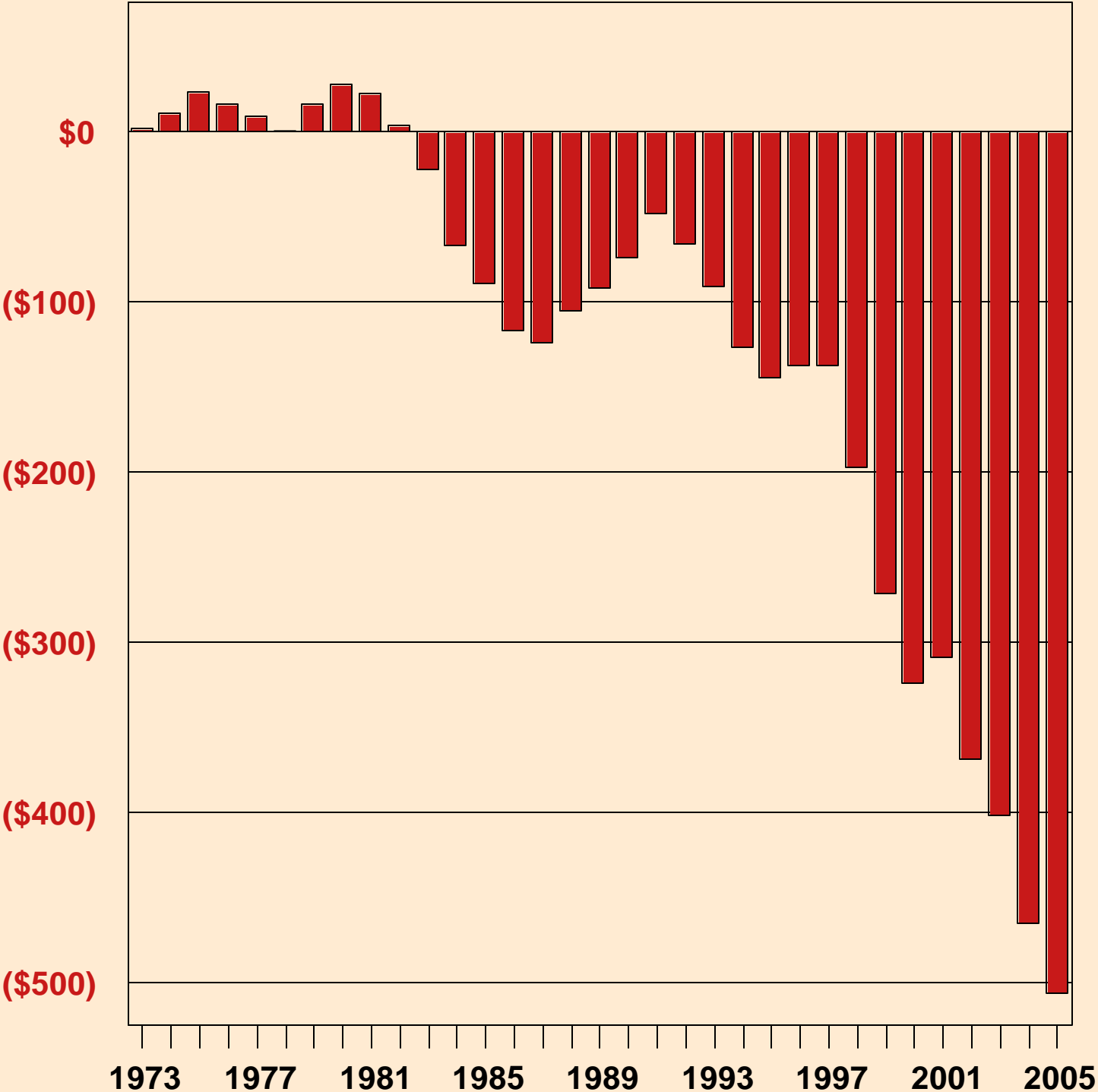

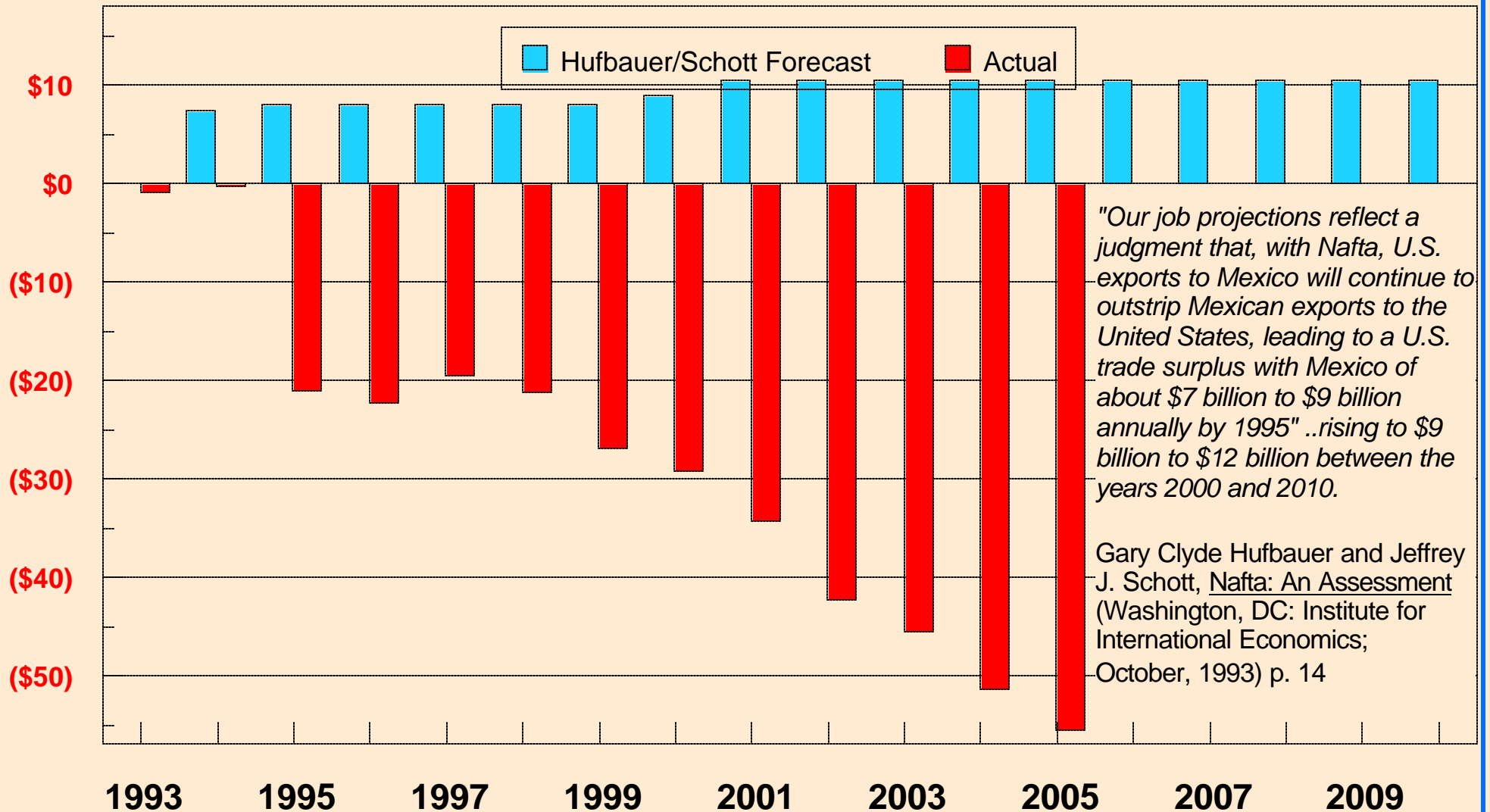

Billions of Dollars: U.S. Annual Current Accounts Balance With Mexico



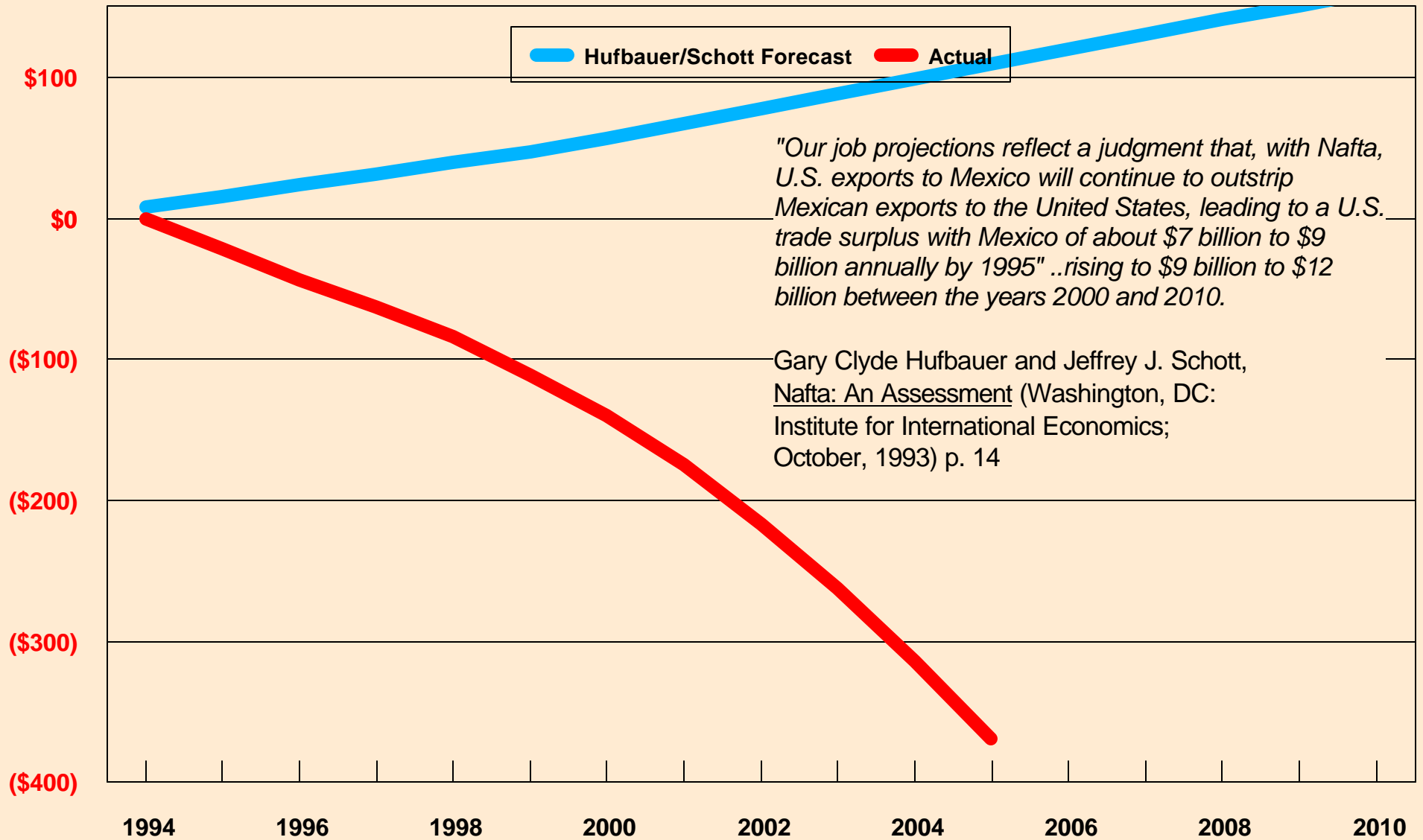

\$ Billions: Cumulative U.S. Current Account Balance With Mexico Since Nafta

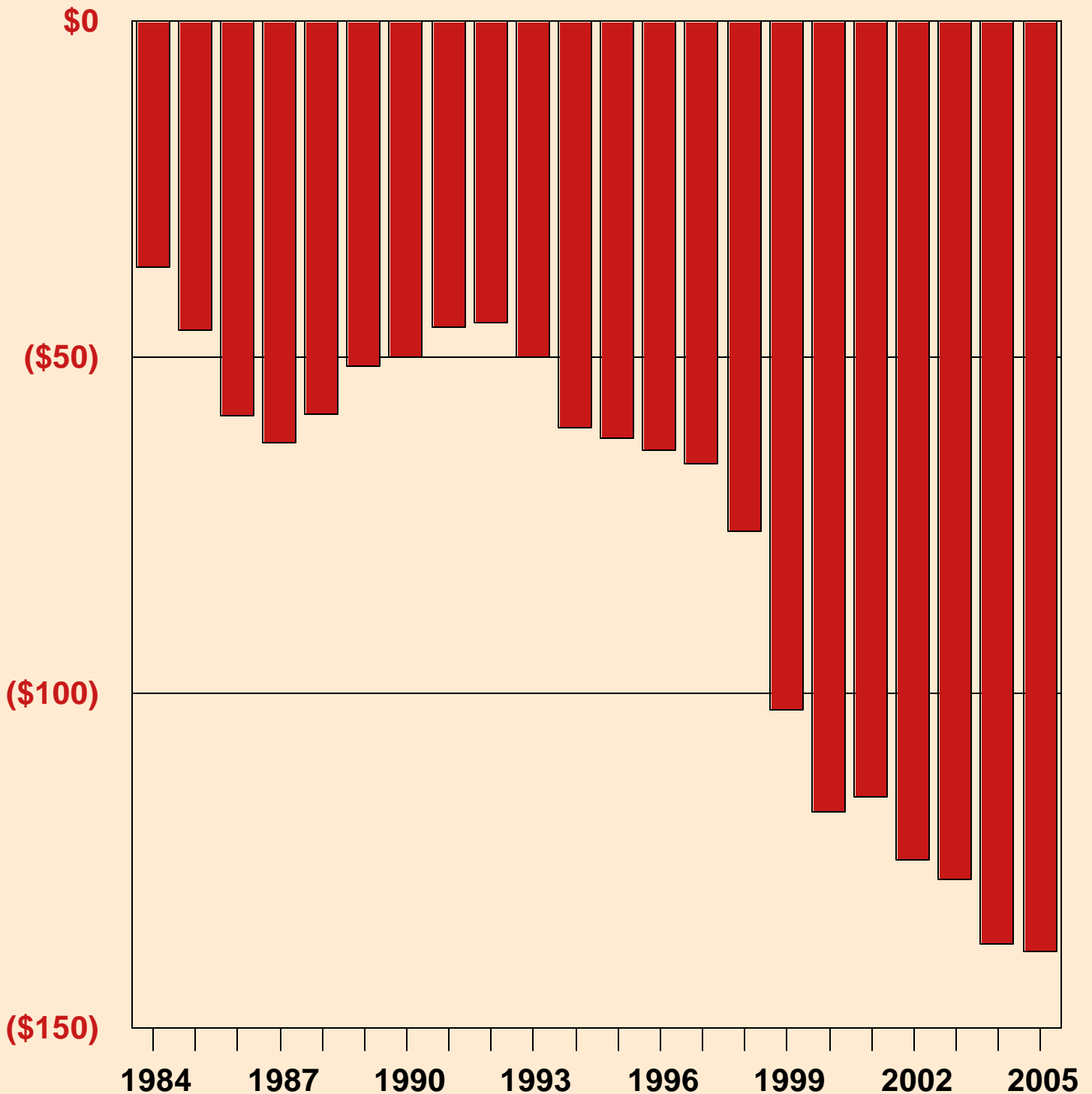

\$ Billions: Annual US Net Exports/Production Shortfall



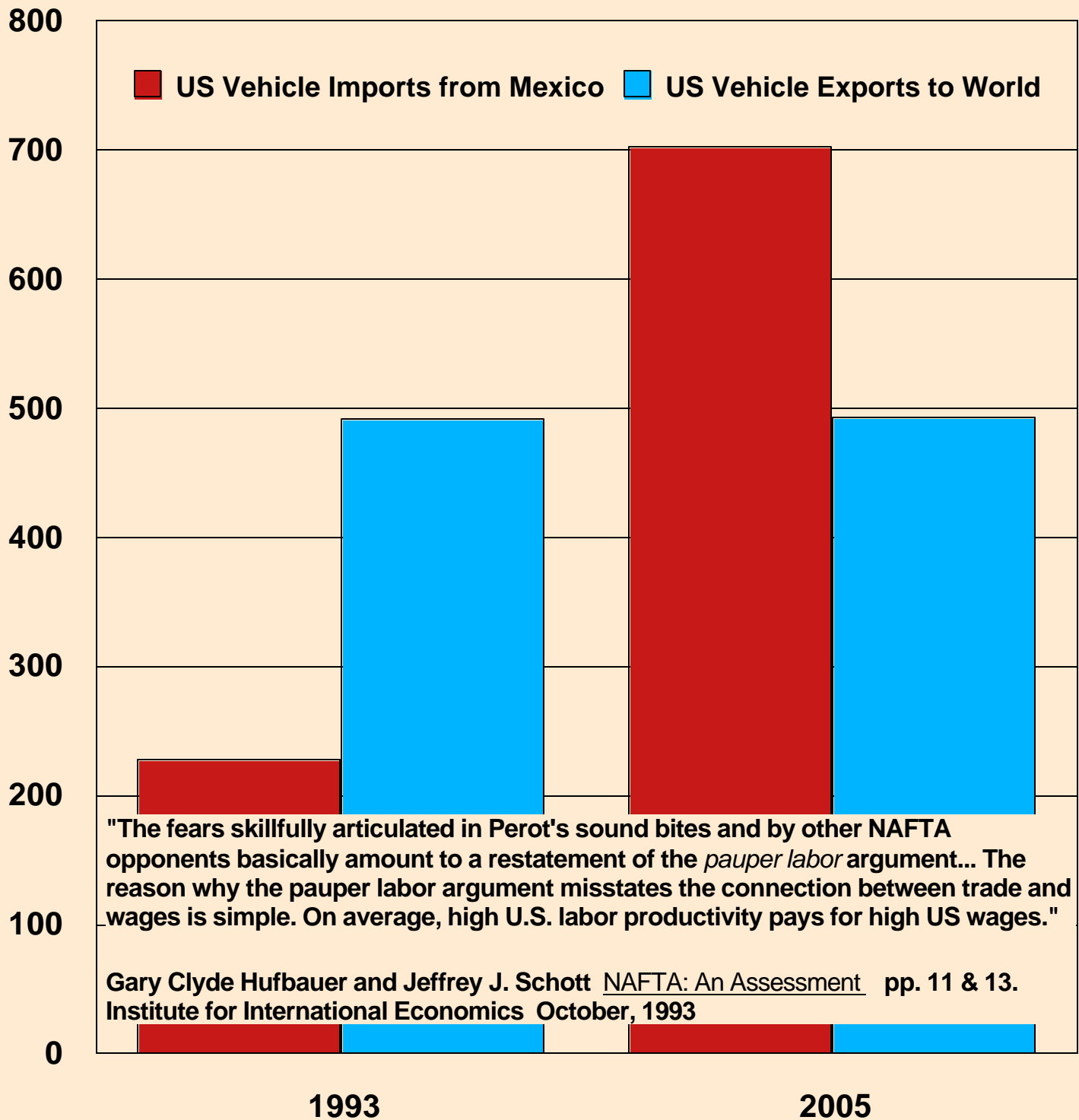

1,000s of Vehicles Each Year



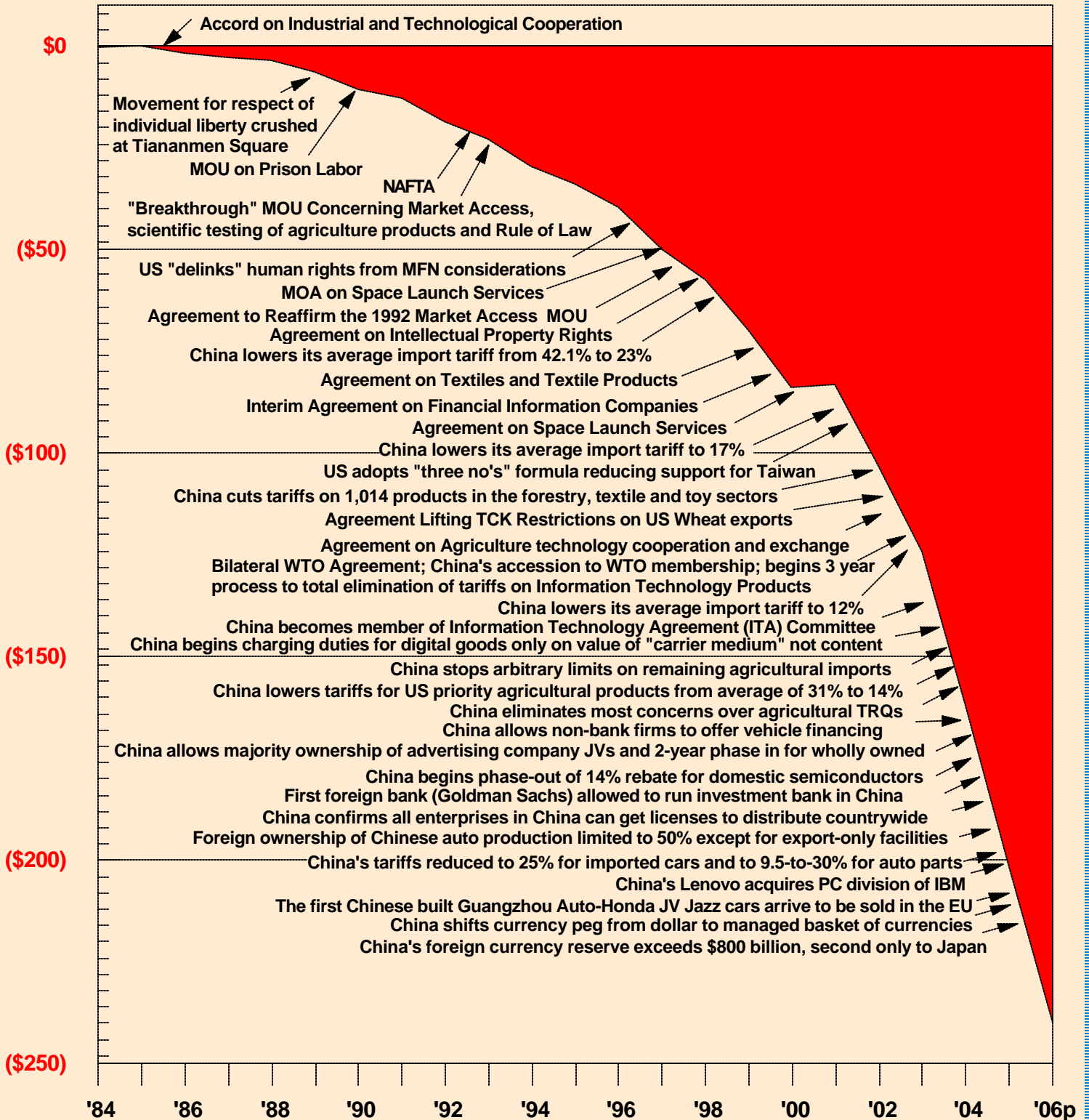
